Alcohol Rules Information Sheet

You have options for serving alcohol:

1. Caterer or Bartending Company provides the alcohol.

You can hire a caterer or a bartending company that has a bar package which would provide you with a bartender and alcohol. You would NOT provide any of the alcohol to the caterer/bartender. If you choose this option, you DO NOT need to get a Banquet Permit from the State of WA. You may either have an open bar or a cash bar. This is the only option you can choose if you want a cash bar. If the Caterer or Bartending Company is NOT on Events on 6th preferred list, they need to provide proof of business license and insurance.

2. You provide the alcohol.

Hire a caterer and hire their bartender, or hire a bartending company, but YOU purchase and provide the alcohol to them to serve. You DO need to get a Banquet Permit. You may NOT have a cash bar. If the Caterer or Bartending Company is NOT on Events on 6th preferred list, they need to provide proof of business license and insurance.

Alcohol Rules:

All alcohol must be served by a bartender.

No alcohol may be served before the bar is open.

No alcohol may be served after the bar is closed.

Any alcohol served before the ceremony must be served by the bartender.

The bar may not be open for more than 5 total hours.

You may only have one bar.

No minors may be served or ever be in possession of alcohol.

No one may be overserved.

No one may take alcohol from the bar or kitchen/storage area.

At no time may anyone bring their own alcohol. The alcohol will either be purchased and provided by you or the caterer/bartender. When you fill out the Banquet Permit you will select the option "Attendees WILL NOT bring their own Alcohol"

All alcohol may only be consumed in the Lounge, Courtyard, and Reception Hall.

No Alcohol in the dressing rooms at any time. If you would like to do toasts in the dressing rooms before the wedding, please talk to Lesley before the wedding day.

No alcohol outside or in the parking lot.

No drinks (or food) in the chapel.

No shots, no jello shots.

No open coolers of beer accessible to guests.

If you provide a keg, only the bartender may tap the keg and serve from it.

If you provide the alcohol, you must have a designated crew to take the alcohol away from the bar when the bar closes. Nobody can take any of this alcohol to drink.

We do not have a bar, just tables. We do have risers enough for two tables to be taller.

Last call must be 45 minutes before event end and bar must close 30 minutes before event end (event end is when guests move to the grand exit and the one hour of cleanup begins).

If these rules are broken, Events on 6th reserves the right to have the bar closed, keep the damage deposit, and /or end the event early.

Progression of dealing with alcohol issues: Three warnings to person(s) and coordinator (and confiscating alcohol), warning of bar shut down and \$100 from damage deposit, bar shut down and \$200 from damage deposit, party shut down and \$200 from damage deposit.

Bodily fluid cleanup is taken from the damage deposit \$150 per instance.
